# THE ADOPTION OF THE FOURTEENTH AMENDMENT

For many years, widespread doubt existed as to the constitutionality of the Civil Rights Act of the United States. Because of this doubt, the Joint Committee of Fifteen formulated the Fourteenth Amendment to the Constitution, which defined citizenship for the first time in the nation's history and protected rights of the Federal government that otherwise could be compromised by the State governments, thus reversing the traditional relationship.

Dr. Horace Edgar Flack's *The Adoption of the Fourteenth Amendment* reviews the purpose and object of this Amendment in historical context while analyzing how Supreme Court decisions during the 40 years between the Amendment's complete ratification in 1868 and his work's original publication gave the Fourteenth Amendment a vastly different meaning than those who drafted it had intended.

The Joint Committee of Fifteen that framed the Amendment had hoped to protect the property and rights of corporations against State legislation of a restrictive character. However, the first section of the Fourteenth Amendment gave rise to more adjudication than any other part of the Constitution, and the Court's interpretation of the Amendment in a number of cases effectively undermined what the framers had tried to accomplish.

In compiling this work, Flack used all of the chief sources of the time, including the Congressional Globe and Record, the Reports of various Committees, and contemporary newspaper accounts. He includes a preface, a review of each of the sections of the Amendment, an appendix on the text of the War Amendments, and a complete index, assuring this work's place as a constitutional law classic.

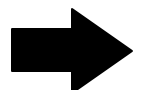

# **THE INTENDED SIGNIFICANCE OF THE FOURTEENTH AMENDMENT**

## **Introducing The First Work Of Its Kind--**

Professor Chester James Antieau, a recognized scholar of constitutional law, worked on this project for nearly twenty years. The fruits of his labor have evolved into the first thorough study of what had been desired and intended by those who proposed the Fourteenth Amendment, and even more importantly, those who ratified the Amendment in the States.

## **An Exhaustive Study--**

It has been understood, since the adoption of the United States Constitution, that the meaning of all its provisions is to be sought primarily in sources which best reflect the understanding of the people who gave legal significance to the document by ratification. In the case of a constitutional Amendment, such as the Fourteenth, the task of scholars and justices is to ascertain what the people of the States who ratified the Amendment intended to effectuate. The best evidence of this, when ratification is assigned to the state legislatures, is to determine what those legislatures believed the Amendment would accomplish.

Professor Antieau's exhaustive study begins with an in-depth probe into everything pertinent said by members of the Pennsylvania Legislature during debates on ratification. He read the biographies of all important Senators and representatives who proposed and moved the Amendment through Congress, then examined their correspondence and speeches, especially when they returned home to explain the proposed Amendment. He continued by studying all papers and journals of the time and by reading the speeches of governors when they addressed the state legislatures called to consider ratification. Finally, Antieau thoroughly evaluated early judicial decisions to indicate what was understood to be the impact of the new Amendment.

The Amendment was intended to provide constitutional recognition and protection of human rights, which the states would be required to honor. Professor Antieau examines the following major parts: The Citizenship Clause; The Privileges and Immunities Clause; The Equal Protection Clause; The Due Process Clause; and an examination of what was expected in shifts of power between the states and the federal government.

This unique work is a valuable guide to constitutional scholars in all areas of the study. The Supreme Court, American Bar, professors of constitutional law, University and Court libraries, Civil Rights organizations, Political Scientists, and historians will find this book an invaluable addition to their library holdings.
