# *World Peace Foundation Pamphlet Series*

---

The World Peace Foundation was founded in 1910 to educate people of all nations about the immense devastation of war, emphasizing its negative effects on both social conditions and on the well-being of future generations.

Though many peace organizations existed in the early 20th century, most of them concentrated their efforts on theory and ideology before eventually dissolving. The World Peace Foundation, however, actively and effectively mobilized public opinion towards the cause of peace through the publication and worldwide dissemination of numerous pamphlets, persisting to this day as a major advocate for international justice.

Now, for the first time, all of the Foundation's pamphlets from 1910-1930 have been reprinted into a single, comprehensive collection. This set of more than **200** pamphlets and other documents from this crucial period in history consists of three separate series published by the Foundation: ***World Peace Foundation Pamphlet Series*** (1910-1917), ***League of Nations*** (1917-1924), and ***World Peace Foundation Pamphlets*** (1925-1930).

Topics covered include the Hague Conferences, treaties, the social and economic costs of war, Pan-Americanism, the outlook for international law, racial and ethnic tensions (particularly between Japanese and Americans), Nazism and colonialism, the League of Nations, and the Permanent Court of International Justice. These pamphlets are of special interest to many researchers—since the United States government failed to ratify the Treaty of Versailles after World War I, the Foundation became the exclusive American distributor of literature for the League of Nations and the International Labour Organization, both of which the U.S. had refused to join.

Aside from specifically war-related issues, these valuable pamphlets also review such important subjects as labor relations and women's peace movements from the 1920s and 30s. Altogether, this significant set serves as a valuable addition to any library's collection of international law and international relations material.
