The nonproliferation of weapons of mass destruction (WMD) and the export controls of conventional weapons and civilian and military dual-use technologies have been one of the most important focal points of international cooperation since the end of World War II. Many international treaties have been signed and many international organizations have been established to promote these nonproliferation and export control efforts.

The United States has been the leader in strongly advocating nonproliferation of WMD and export controls of civilian and military dual-use goods.
