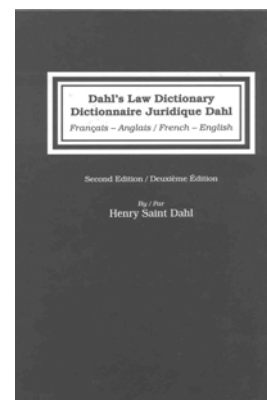

The book not only contains short definitions based on synonyms, but also authoritative definitions, which transcribe directly the relevant parts of codes, statutes, judicial decisions, and legal writing in an encyclopedic nature.

While English may be considered “the language of business,” French is the official or business language of many countries in Africa, the Americas, Asia, and Europe (including Canada, Switzerland, Belgium, Vietnam, the West Indies, Morocco, Zaire, and Haiti). It is also one of the official languages of the United Nations, the International Court of Justice at the Hague, and the EU institutions, and has played an important role in the creation of the laws in numerous countries of Latin culture.

Henry Saint Dahl's bilingual legal dictionary indicates the sources of each definition and is devised to help English and French readers alike, making this important work a valuable addition to every law library reference shelf.

Dahl's Law Dictionary (Diccionario Juridico Dahl) is the only bilingual legal dictionary containing encyclopedic definitions. The English reader will be able to understand Spanish and Latin American legal concepts through definitions pulled from such crucial sources as the five basic legal Spanish codes (Civil, Commercial, Criminal, Civil Procedural, and Criminal Procedural), the Civil Code of Louisiana (once a Spanish territory), the Standard Penal Code for Latin America, and decisions from the Puerto Rico Supreme Court.

The Spanish reader will have access to the American legal system through fundamental legal sources such as the United States Constitution, the Uniform Commercial Code, the Model Penal Code, the Federal Rules of Civil Procedure, the Federal Rules of Criminal Procedure, four Restatements of the Law (Conflict of Laws, Contracts, Judgments, and Torts), and decisions from the Supreme Court of Puerto Rico defining American terms.

For the reader who is having difficulty in locating a word or concept, the dictionary provides a Table of Key Words broken down by subject matter, which allows the reader to focus on a particular area of interest. This dictionary is recommended for any library or law firm serving Hispanic clientele.
