The author has included *Editorial Notes* along with each document providing **three** types of additional information: the dates on which each treaty was signed or adopted and entered into force; the total number of parties to the treaty as of 2007; and a list of Further Reading about each specific document, including books and articles that offer relevant and helpful commentary and analysis to guide the reader's research.

Each document reproduced here has been carefully checked against an authentic hard copy of that document. The *United Nations Treaty Series*, *United States Treaties and Other International Agreements*, and *International Legal Materials*, as well as various Internet sources, were consulted in preparing this work.

Hafez has **brought together** a collection of documents covering all important areas of international law and has organized the contents into thirteen chapters according to subject matter. Within each chapter, documents are presented chronologically, with the exception that dependent instruments are conveniently located together.
