The Continental Confederation Congress molded the fledgling United States of America, shepherding through the Articles of Confederation, setting policies, both foreign and ‘domestick,’ and guided the birth of the nation. Its mission came to fruition with the adoption of the U. S. Constitution in March 1789. This 4-volume set brings to light the confidential discussions behind the policies and procedures that would dominate the new government for the next two centuries.

Under the direction of President James Monroe, and through resolutions of Congress of May 27, 1818 and April 21, 1820, the *Secret Journals* were first published in book form in 1821. The Journals were secret until this time due to their sensitive nature. The Confederation Congress dealt with issues centered around attaining peace treaties and establishing commerce with other nations as they kept a watchful eye on Great Britain (a peace treaty was signed in 1783) and its presence in Canada. Congress also had to overcome such impediments to domestic trade as a long-lasting confrontation with the King of Spain over navigation rights on the Mississippi River.

The first book of the 4-volume set deals with Domestic Affairs and the History of the Confederation. The remaining three books are devoted to Foreign Affairs preceding the adoption of the U. S. Constitution. In one of its last sessions on September 13, 1788, the Confederation Congress performed one of its most important tasks—it adopted a resolution organizing the new government, and scheduled its next meeting under the new Constitution of the United States to convene “on the first Wednesday of the ensuing March.”

Few figures in early American history generated as much controversy as Robert Yates, who, though respected for his service as the Chief Justice of the New York State Supreme Court, was harshly criticized for his impartial treatment of British Loyalists after the American Revolution. Then, while representing New York at the Constitutional Convention in 1787, he caused even more displeasure among his peers by walking out of the Convention in protest, claiming that the delegates were greatly exceeding their designated authority. Along with fellow New York delegate John Lansing, Jr., Yates believed that the proposed Constitution dangerously centralized power. Their beliefs differed distinctly from those of the third New York delegate, Alexander Hamilton, and leading Federalists John Jay and James Madison, who asserted that Yates and Lansing had “reported in angry terms what they observed with jaundiced eyes.” (The views of Hamilton, Madison, and Jay on the Constitution are represented in *The Federalist*, also available from Hein - see above). The book also **contains a valuable appendix** that includes a draft of the Constitution, **the Constitution itself** (and its Amendments up to the time of original publication), a list of the members of the Convention, and a letter from Yates and Lansing outlining their reasons for not subscribing to the Constitution.
