### ***What's included in the current online subscription model?***

Current content provides online access to each new issue as soon as it becomes available. Online access also includes all historical volumes of the journal, making the entire archive fully searchable in an online format.

### ***What's in Hein's "current content model"?***

Our current content model contains the most recent issue of the journal published, and is the only place where those issues can be found online. Volume 26 Issue 1 is the first material going in as current content for this journal. PLEASE NOTE: For the initial current-content release of this journal, we have included all of the previous volumes.

### ***How will I know when new articles are available in the current online subscription?***

You can create an eTOC alert using a MyHein account in HeinOnline. After creating an eTOC alert for the title, you will receive an email notification alerting you when new content is added. The email will contain the table of contents for the issue and a link to the article(s).

### ***Are you subscribed to HeinOnline's Law Journal Library?***

If you subscribe to Harvard Journal of Law and Technology in the current online subscription model and you are subscribed to HeinOnline's Law Journal Library, the full text of the current articles will be fully integrated and accessible directly from within your Law Journal Library subscription. This means you can search across all articles of the journal in conjunction with all other law review articles in the Law Journal Library. You can browse to the title and access the full text of every historical volume and article from within the Law Journal Library. Lastly, you can quickly link to other law review articles that are cited in the Harvard Journal of Law and Technology if they are available in HeinOnline.

We have just begun publishing Volume 26 Issue 1, therefore Volume 26 is the current content for this journal. Once Volume 27 is published, Volume 26 becomes part of the historical back file.
2. You must be subscribed to HeinOnline's Law Journal Library in order to access the journal within the Law Journal Library.
3. HeinOnline indexes all recent content in the Law Journal Library, thus allowing you to browse or search across all volumes of the journal. You will be able to view the indexing for Volume 26 when browsing titles and in your search results; however, in order to access the full text of the articles you must be subscribed to the Journal's current online subscription model.
4. You can create an eTOC alert for this title, but if you are not subscribed to the current online subscription model, you will not be able to access the full text of the new content.
