

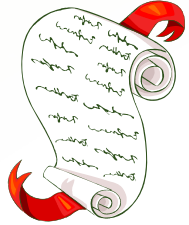

Treaties and agreements between nations are indispensable tools for diplomacy. In every period in history when war was a threat or in progress, or when a ruler of one state coveted land belonging to another sovereign state, treaties and secret treaties were negotiated, concluded, signed, ratified, and implemented—and often breached.

From the earliest identified secret treaty in 499 between Godegisile, one of the kings of Bourgoigne, and Clovis, King of the Franks, through the Classified Religious Freedom Agreement between the United States and Vietnam in 2005, Professor Edward Grosek has compiled this exceptional reference work detailing nearly 1,000 secret treaties and agreements spanning more than 1,500 years.

For the very first time, treaty researchers now have a one-stop resource to begin or enhance their own research into these clandestine relationships that were often created to deceive or topple the government or leaders of another nation. These “behind-the-scenes” acts reveal hidden intentions that oftentimes contradicted the world’s view of one nation’s feelings towards another.

Grosek's informative book is organized into a **chronological listing of the 973 documents** identified, including an informative annotated bibliography of the sources for texts of and information on these secret treaties, an essay on where to begin one's research on pre-1648 treaties to educate the in-depth treaty researcher, and an index by country for those researching secret treaties of specific countries.

Grosek's book is a recipient of the American Association of Law Libraries' **Joseph L. Andrews Bibliographical Award**, which is bestowed annually on the most significant contribution to the legal bibliographical literature, measured primarily for its creative, evaluative elements and the extent to which judgment was a factor in its formation.
