Dr. Christopher T. Anglim's *The Iraq War (2003)* examines this crucial question and other important issues relating to this controversy, bringing together **464 legal documents** which show the development and the differing interpretations of law as applied to the facts of the War.

The work compiles the relevant material concerning the conflict, including documents from the U.S. Congress, Presidential statements and orders, and documents from federal departments and agencies, such as the U.S. Department of State and the Central Intelligence Agency (CIA). It also includes resolutions and statements from the United Nations; documents from the United Kingdom and other nations presenting their positions on the War; and proposals to reconstruct postwar Iraq.

This valuable set contains an extensive and informative introduction, providing a historical overview of the legal controversies involved. In addition, it presents a comprehensive chronology of Iraqi history dating from the Ottoman conquest in 1533 up to the bombing of southern Iraq and Baghdad by U.S. and U.K. forces on March 20, 2003.
