LEGAL L.C. SUBJECT HEADINGS LISTS IS NOW AVAILABLE IN HEIN'S CURRENT CONTENT SUBSCRIPTION MODEL!

Legal L. C. Subject Headings Lists (LLCSHL) contains a selection of subject headings from the lists posted by the Library of Congress Policy and Standards Division. Up until 1995 the subject heading lists were issued by L.C. in paper format, and LLCSHL will continue to be published in print format as a service to law librarians; however, now it is also *available through Hein in its current content model!* The subject headings posted by Library of Congress are accepted as the worldwide standard, and are a by-product of the system in the Subject Cataloging Division for the submission, review, and approval of new, changed and canceled subject headings and

references. The headings selected by editor Melody Lembke which appear in *Legal L.C. Subject Headings Lists* are legal terms or others commonly assigned to the literature of law or closely related subject areas.

Legal L.C. Subject Headings Lists provides quarterly cumulations of the selected subject headings arranged in a single alphabetical order. In addition to the obvious advantage of only one alphabetical list to consult for each year, every entry new to the quarterly cumulation is indicated with an asterisk and thus acts as a current awareness tool. This feature should be useful to public service librarians as well as catalogers. The original L.C. list number is added in brackets following the subject heading as a convenience, in case the user should need to consult the original.

For those subscribed to both *Legal L.C. If you do not subscribe to the current content model, you will only have access to the the historical backfile of this material in Spinelli's Law Library Reference Shelf.
